## **BISHOP'S MESSAGE FOR APRIL 2018**

I wish every one of you a happy and joyous Easter. May the Risen Lord bring in us new zeal, strength and fervor to extend the Kingdom of God and increase our life of faith to greater heights. Life of Jesus is lived by us every day. As He suffered as per the rule of God and died for all of us in order to lead us to the love of the Father. Let His passion and death help us daily to live our Christian life faithfully.

I thank Rev. Fathers who attended the mass of the Chrism on 22 March. I thank the preacher Rev. Fr Dionysius Vaz, Rector of St Aloysius College who has given us good points to our recollection. The holy oils are kept in the reception of the Bishop's House; please collect them from 2 April. We maintain a list of those who take the holy oils. Those who have forgotten to take them last year, please take them this year instead of reminding you of it.

In this month, the seminarians of our diocese as last year will have some courses. This is part of their formation. The parish priests are requested not to ask for their services. They will miss time. This year all their activities during the summer vacation end on 14 evening excepting those who have gone to Gulbarga mission. Brothers are at home for more than one month. Please make use of their services. Parish Priests, please promote vocations for Mangalore Diocese. We too need good vocations. If there are boys who show the signs of joining the seminary, please send them for vocation camp conducted by Fr Jagdish Pinto, Vocation Director, on 7 & 8 of April.

This is a season of marriages also. You are once again reminded to follow the rules in our diocese – pre-marriage preparation, 3 months interval before marriage – a period to know each other and families as far as possible. Please encourage them to follow the above rules in their own interest. Quite a number of marriages get broken because of lack of knowledge of the partners and their families. It is very painful and sad to hear the woes of the couples who either married hurriedly not

knowing the age, education, profession, the nature of the person etc. Let us try our level best to safeguard the marriages of our faithful. We need good families. You have read in the Internos the number of marriages come for annulment.

The marriages of different religions with a catholic are not to be celebrated with usual solemnity. It is only a contract akin to that of taking place in the civil registrar's office. It is only the parents to their prestige make you restless and irritate you to invite priests to make solemn. They also quote that in some parishes such marriages are solemnly held. The religious priests attend such marriages and they indulge in doing the ceremonies which they are not allowed in our diocese. By doing such things are we encouraging marriages of our Catholics with non Christians? At the same time people are disturbed that the priests are encouraging such marriages. As per canon law there cannot be 2 marriages to the same couple except the civil marriage as per the requirements of law of the country. While the Catholics knowing that they are happy to marry in a non Christian rite still they insist upon a marriage in the church with a Catholic rite. Please take this matter seriously and tell the catholic party the consequences of such marriages. For us marriage is a sacred institution; it is a domestic church and people living in this institution further the church and the Catholic community at large. I thank you for your cooperation and good will towards me. I do pray for you. Please remember me in your prayers. May the Risen Lord make your lives happy and joyful. May God bless you.

**II. INFORMATION FROM CODP****(1) EDUCARE LOAN 2018-19****Sub: Inviting applications for Educare 2018-19**

Dear Rev. Parish Priest & Parish Council Members,

Easter Greetings from Fr. Oswald Monteiro, CODP.

Educare, a programme of CODP, is looking forward for another year of support for higher education to financially less privileged students of Mangalore and Udupi Dioceses. Educare provides interest free loans with an objective of ensuring meritorious students with high aspiration to successfully realize their dream of higher education and transform them as agents of change in their families and in the community.

Started in 2013, Educare programme is a revolving loan facility to needy students. It is therefore mandatory that students must repay the loan within a period of 18 months after completion of their education in order that same funds are made available to next set of needy students who look forward for a similar educational support. To date, Educare has supported 2290 needy students in both dioceses during the last 5 years.

This year onwards, all Educare loan applications **MUST** be submitted to respective parish offices at least 10 days prior to last submission date. A committee appointed by the Parish Priest will screen and evaluate the need of students for Educare loan. Similarly, the same committee is now entrusted to ensure timely repayments by Educare beneficiaries.

While I specially pray for the donor of Educare, I remain grateful and indebted to all Parish Priests and Parish Council

members who have been actively supporting our effort in furthering the objective of Educare within parishes. Primarily, the success of Educare depends on the correct selection of students within the parish and repayments within the due date. We have received a whole hearted and proactive support from all parishes during our visits and look forward to their similar support in the future as well. It is our opinion that, the parish wise concerted efforts will take forward the Educare to a new height and our young students will have a wonderful future.

### **Rules and Regulations**

#### **I. Student's eligibility (Freshers)**

- a. Minimum qualification required to apply for Educare loan is II PUC or equivalent in a 10 + 2 education system. The loan is applicable **only** to those students applying for courses where II PUC or equivalent (10 + 2) is the minimum qualification required such as Graduate or Post graduate degrees or University recognized Diplomas.
- b. Student must have scored minimum of 60% marks for General courses like Graduation, Post graduation, Diploma and nursing courses and 75% marks for Professional courses like Engineering, Medical, Hotel Management in pre-graduation examinations. If excellent ranking is secured in qualifying entrance test like NEET/CET/COMEDK, relaxation up to 70% may be considered subject to decision of the Educare committee.
- c. Students applying for correspondence courses, part time courses, private studies and specific job courses at tutorials are not eligible to apply for this loan. This loan is only for those students pursuing regular university level degrees or diplomas.
- d. The Annual income of the entire family from all sources (both parents and any unmarried siblings) should be less than Rs. 3,00,000/- (Rs. 3 lakhs only)



- e. Only Catholic students domiciled in Mangalore and Udupi Dioceses can apply. (Proof of residence must be produced.– such as MESCOM bill for present residence in the name of either parent or last school leaving certificate.)
- f. Overseas studies are not supported by Educare.
- g. To be eligible to apply for this loan, the student must have received the Government scholarship for minorities for the previous year (Proof of receipt of such scholarship must be produced.)
- h. Only those students who get admission under NEET/CET/ COMED-K or any equivalent government competitive examinations will be considered. (Proof must be produced.)  
EDUCARE DOES NOT SUPPORT MANAGEMENT SEATS.
- i. A maximum of two siblings per family is supported.
- j. INCOMPLETE AND MISREPRESENTED APPLICATIONS WILL BE REJECTED WITHOUT NOTICE.

## II. Student's eligibility (Renewals)

1. Student must obtain minimum of 60% marks in their last qualifying exam. Proof of marks obtained must be produced at the time of the interview. Those students, who have not obtained 60%, please do not apply for this loan.
2. Please ensure that all the documents are submitted at the time of application or at the time of interview. Failing to submit marks cards or required documents of pervious examination will result in rejection of the application.

Fresh and renewal students can submit their applications **online from 1<sup>st</sup> May 2018 onwards but before due dates specified below. Submission of loan application is accepted even if the student admission is at a later date.** Students are advised to read instructions before completing the form and make sure that all the relevant documents are available to proceed with the application.

**The Educare executive committee supervising the loan disposal is the final authority for approval and disbursement of loans. The committee reserves the right to reject any application that in its view is not genuine, not deserving, and incomplete without providing any explanation to the applicant.**

**III. Application submission process:**

1. Students' desires of applying for Educare loan must go to the website and submit application online.
2. Then take the printout of the application and obtain the required recommendation and signature and submit their application to their respective church offices at least 10 days before the last date of submission notified for 2018.
3. All applications received in church office to be placed before a committee appointed by the parish priest i.e. finance committee or Education committee.
4. The appointed committee to screen/evaluate and approve genuine applications for Educare loan duly signed by the Vice President of the PPC and the Parish Priest.
5. Such approved applications may be forwarded to CODP directly by the parish office or may be handed over to students to be submitted to CODP prior to due date specified for 2018.

**IV. Documents required at the time of submitting the application are:**

1. Completed application signed by Gurkar, PPC Vice President and Parish Priest.
2. Copy of Aadhaar card
3. Copy of Ration card
4. Copy of latest marks card (May be submitted at a later date)
5. Copy of latest electricity bill/MESCOM bill
6. Proof of other scholarships applied/received

## REGARDING INCOME TAX

The Income Tax Returns filed for FY 2016-17 AY 2017-18 are being are being Processed by CPC. It appears there is a Bug in their Software due to which the Income Computed u/s 143(1) of the Act, appears as Zero. This is happening across dioceses and states.

Also some of the parishes / Bursars, Financial Administrators would have received messages which reads ‘Refund Issued for PAN AAxxxxx1M for Assessment Year 2017-18 has failed due to Mandatory field missing: (Account Number/IFSC Code/Account Name/Account Type/Address1/City/State/PIN code), for reissue please use online services.’

This again is due to a Bug in the Departmental Systems, where a refund sequence Number is generated without a corresponding refund. You will have to file a rectification application for the same. Hence if you have received an email from the income Tax Department with the title ‘Intimation U/S 143(1) for PAN AAQxxxxx8N AY:2017-18’ Please forward the same to your respective Auditors, so that they can take up the matter with the Department.

In section 11 of the Income-tax Act, in sub-section (1), after Explanation 2 [as inserted by section 11 of the Finance Act, 2017], the following Explanation shall be inserted with effect from the 1st day of April, 2019, namely:—

Explanation 3.—For the purposes of determining the amount of application under clause (a) or clause (b), the provisions of sub-clause (ia) of clause (a) of section 40 and sub-sections (3) and (3A) of section 40A, shall, mutatis mutandis, apply as they apply in computing the income chargeable under the head “Profits and gains of business or profession”.

What does this Mean to Charitable and Religious Trusts / Societies:



1. Non-deduction or non-payment of TDS on payments made to residents as specified in section 40(a)(ia) of the Act, the disallowance shall be restricted to 30% of the amount of expenditure on which TDS is not deducted. In other Words if Rs. 100,000 is Paid to an Architect without deduction of TDS then 30% of Such Payment will be Treated as Income of the Charitable or Religious Trust and Tax Levied Thereon. Therefore please ensure that TDS is deducted on All Payments to Contractors. TDS on Contractors at 1% for Individual Contractors whose 4th Character in the PAN is 'P' (e.g: PAN: ADIPG6123D) and 2% for all Other Characters shall be Deducted if a Single Bill Exceeds Rs. 30,000/- or Aggregate of Bills in a Year Exceeds Rs. 1,00,000. In the case of Lawyers, CA's, Architects, Engineers etc TDS at 10% to be deducted if any Payment Exceeds Rs. 30,000/-.
2. 40A(3) and 40A(3A) - Aggregates of Payments to a Person in Cash above Rs. 10,000/- The entire amount Paid in Cash shall be disallowed and Treated as income of the Trust. For e.g.: A Contractors Bill of Rs. 3,00,000/- is Paid in Cash. In such case the whole Payment will be treated as Income of the Trust. However there are certain Exceptions such as Deposit of Cash into Bank Accounts, Payments to the Government, and the Following where this Rule won't be enforced:
  - (e) where the payment is made for the purchase of
    - (i) agricultural or forest produce; or
    - (ii) the produce of animal husbandry (including livestock, meat, hides and skins) or dairy or poultry farming; or
    - (iii) fish or fish products; or
    - (iv) the products of horticulture or apiculture, to the cultivator, grower or producer of such articles, produce or products;
  - (f) where the payment is made for the purchase of the products manufactured or processed without the aid of power in a cottage industry, to the producer of such products;

- 
- (g) where the payment is made in a village or town, which on the date of such payment is not served by any bank, to any person who ordinarily resides, or is carrying on any business, profession or vocation, in any such village or town;
- (h) where any payment is made to an employee of the assessee or the heir of any such employee, on or in connection with the retirement, retrenchment, resignation, discharge or death of such employee, on account of gratuity, retrenchment compensation or similar terminal benefit and the aggregate of such sums payable to the employee or his heir does not exceed fifty thousand rupees;
- (i) where the payment is made by an assessee by way of salary to his employee after deducting the income-tax from salary in accordance with the provisions of section 192 of the Act, and when such employee (i) is temporarily posted for a continuous period of fifteen days or more in a place other than his normal place of duty or on a ship and (ii) does not maintain any account in any bank at such place or ship;
- (j) where the payment was required to be made on a day on which the banks were closed either on account of holiday or strike;
- (k) where the payment is made by any person to his agent who is required to make payment in cash for goods or services on behalf of such person;
- (l) where the payment is made by an authorised dealer or a money changer against purchase of foreign currency or travelers cheques in the normal course of his business. Explanation. For the purposes of this clause, the expressions “authorised dealer” or “money changer” means a person authorised as an authorised dealer or a money changer to deal in foreign currency or foreign exchange under any law for the time being in force.]

**The above proposals of the Budget will become Law from 01.04.2018.**

In Several cases we have come across we see that the banks have reversed the Interest paid on SB accounts of the church/ Institutions on the pretext that the Church is 'ineligible' to open and operate a SB account. In the case of Gardady Church the Interest so reversed exceeds Rs. 1,50,000 (which after our intervention has been re-credited to the account of the church). If you find that such debits have been done please contact us as the same is illegal and contrary to the law laid down by the Government and RBI.
