BISHOP'S MESSAGE FOR SEPTEMBER 2022

Papal Intention for September: Pope Francis invites the whole Church to pray so that the death penalty may be legally abolished in every country. In his address to the Participants in the meeting organized by the Pontifical Council for the Promotion of the New Evangelization (11 October 2017), he categorically affirmed: "It must be clearly stated that the death penalty is an inhumane measure that, regardless of how it is carried out, abases human dignity. It is per se contrary to the Gospel, because it entails the willful suppression of a human life that never ceases to be sacred in the eyes of its Creator and of which – ultimately – only God is the true judge and guarantor. No man, 'not even a murderer, loses his personal dignity'." In India, there is often a strong demand for the death penalty for certain crimes, believing it will deter the perpetrators of evil. As opposed to the general tendency in many parts of the world, the Pope insists that "no matter how serious the crime that has been committed, the death penalty is inadmissible because it is an attack on the inviolability and the dignity of the person". Let us join the Pope in making serious efforts to abolish the death penalty from the face of the earth.

Recent Amendments to the Income Tax Rules: On 10 August 2022, the Ministry of Finance issued new rules applicable especially to the Charitable and Religious Trusts and Societies that enjoy tax exemption. Other than the regular requirements, a few more are added. A serious attempt has to be made to make our Trusts and Societies 100% compliant. Therefore, it is expedient that a discussion on the rules connected with Income Tax amendment regarding books of account, documents to be kept ready and drafting of minutes and resolutions is to be organized for Parish Priests, Heads of Institutions, Vice Presidents, Secretaries and Accountants. We shall divide the group into four to have greater interaction. We shall have the discussion on 16, 17, 18, and 21 November. The deanery-wise division and the place of the programme will be intimated later. A short summary is given in this *Inter Nos*. However, a certain amount of training is needed to align with the demands of the Government regarding this serious matter.

For the Parishes and Institutions, being Trusts/Societies, with tax exemption, we need to keep the record of:

- a) All the training programmes, number of participants, the activities conducted, and the photos of the programme.
- b) Each Commission should maintain the name, Parish, phone number of the members of the Executive Committee, and photos of activities.
- c) The minutes and resolutions of the PPC and PFC and their activities are to be recorded correctly.
- d) The Parish should have a ready list of all the members of the PPC and PFC, with addresses and phone numbers.
- e) The name of the Coordinators of the Parish Commissions should be maintained in the Parish, and a copy is to be sent to the Diocesan Coordinator with the addresses and phone numbers.
- f) Keep ready the list of all the secretaries of the Commissions at the Parish level, the name of the Commission, and mobile number. A copy could be marked for the use of the Diocese.

The Nativity of Blessed Virgin Mary: The month of September brings smiles on the faces of children and adults. Mary is the Cause of our Joy. Her birth announces the hope and daybreak of our salvation. For us Christians of the Western Coast, the Nativity of the Blessed Virgin Mary also signifies family unity. The families present the new corn that demonstrates the freshness of life. Added to it is the significance of a girl child in our family and society. These multiple realities make our feast ever richer. Baby Mary makes the children to giggle, and adults rejoice seeing their children carrying baskets with flowers. May the colourful feast make our lives full of cheer and unite our families all the more. Let us gratefully acknowledge the gift of every person in the family and thank God for his immense love. In order to facilitate the celebration, Mangala Jyothi has prepared the prayers to be used at the novena and at family prayer. Let us ask Mother Mary to intercede for us in all the difficulties that surround us.

Four Years of Episcopacy: On 15 September 2022, I will be completing four years as the Bishop of Mangalore. I sincerely thank everyone who has journeyed with me in the pastoral care of the People of God. I wish you all a joy-filled feast of the Nativity of Our Heavenly Mother.

SUMMARY OF THE NOTIFICATION FROM THE INCOME TAX DEPARTMENT DATED 10 AUGUST 2022

As informed by the auditors, the Income Tax department has made amendments to the Income Tax Rule no. 17A and inserted Rule no. 17AA. As per this amendment all the Institutions, Trusts, Educational Institutions and such other institutions which are under the exempted category are supposed to maintain the following books of account and documents with immediate effect. The points below are a summary of the notification which are applicable to our Parishes and Institutions.

As per the notification, our Parishes and Institutions have to keep the following records.

- a) Cash book, ledgers, journals, original bills and documentary evidence for all the transactions and any other books/ documents that is required to support the transactions of the Parish/ Institution, all its units and projects under the Parish/ Institution.
- b) Details of all the donours with name, address, PAN (if available) and Aadhaar (if available) to be maintained as an official register of Parish. (Donour's Register)
- c) Details of all the Income other than donations. (Income from Properties or others)
- d) Details of the persons to whom payments or credits are made with respect to revenue and capital expenditure and the purpose of such expenditure.
- e) Name, address and PAN (mandatory) of the persons to whom **donations** are made from Parish / Institution account.
- f) Details of utilization of income, whether the income is of the previous year, current year or any other sources.
- g) Details of all the investments or deposits of the year. (Investment Register)
- h) In case of loans or borrowings, details of the lender with name, address, PAN (mandatory) and Aadhaar (mandatory).
- i) Loan details such as date, amount, purpose of such loans, utilization of such loans and its repayments.
- j) Details of all the immovable & movable properties. Location, nature, cost and value of such properties and the registered documents (a detailed Asset Register)
- k) In case of transfer or sale of properties, the net consideration received. The details of utilization of such consideration in capital assets.
- l) Names, address, PAN and Aadhaar of Authors/Founders, Trustees, Managers and donours who have contributed more than Rs.50000/-.

- m) Details of transactions/payments to Authors/Founders, Trustees, Managers and donours who have contributed more than Rs.50000.
- n) Records such as name, address and objectives of the Projects, units and the institutions run by the Parish/Institution.

The above said documents are to be kept and maintained in the registered office or any place as decided by the management of the entity by way of resolution (to be intimated to the tax authorities). These documents are to be maintained for a period of 10 years in written form or electronic/digital form. In case of pending assessments, the documents are to be maintained until the assessment is completely over.

The heads of the Institutions and the Parish Priests are to take this matter seriously and follow it from immediate effect. The consequences of not following these rules might affect our Institutions and Parishes of losing the tax exemptions, benefits of the provisions of corpus donations, accumulations and all the other provisions of Sec 11 and 12 of the Income Tax Act.

Revised Gospel Acclamation - Alleluia: (Reminder): As per the direction of the Congregation of the Divine Worship and Discipline of the Sacraments (CDWDS) to the Commission for Konkani Translation of the Revised Missal to retain ALLELUIA in our liturgy, it is advisable that we sing only ALLELUIA and avoid Alle, Allelu, Jai Jai and Sorvesporak Jai Jai, eventhough this new Missal is in the final stages of completion. I propose the Parish Priests to instruct the choir / those who lead singing in the parish. Mangala Jyothi has prepared the Audio for Alleluias for every liturgical season and celebration of the sacraments. They are available on the Diocesan Youtube channel. The musical notation is now available at our stall.

2. New Novena Book for September 8 - Monthi Feast: We have published new novena book for the feast of September 8. We have translated the original novena prayer from Italian to Konkani. POPE FRANCIS ON PRIESTS' ATTACHMENT TO MONEY

“Our people forgive us priests many failings, except for that of attachment to money. This they don't forgive. It is not so much about money itself, but the fact that money makes us lose the treasure of mercy. Our people can sniff out which sins are truly grave for a priest, the sins that kill his ministry because they turn him into a bureaucrat or, even worse, a mercenary. They can also recognize which sins are, I won't say secondary (I'm not sure if you can say this theologically!), but that have to be put up with, borne like a cross, until the Lord at last burns them away like the chaff. But the failure of a priest to be merciful is a glaring contradiction. It strikes at the heart of salvation, against Christ, who “became poor so that by his poverty we might become rich” (The Third Meditation for Priests and Seminarians, 2 June 2016).
