BISHOP'S MESSAGE FOR MARCH 2023

Papal Intention for March: In this month, Pope Francis invites us to pray for the victims of abuse from the members of the Church. He desires that the victims find within the Church herself a concrete response to their pain and suffering. The members of the Church must take all the precautions with the utmost care not to hurt children and vulnerable adults. The Church must take proactive measures and adequate steps to ward off the menace of abuse at any time. How can the Church who is called "an expert in humanity", be the cause for such deep wounds? She must do everything possible for humanity so that every person truly finds the authentic meaning of life. St Irenaeus said: "Gloria Dei vivens homo": the human person who fully lives his or her dignity gives glory to God, who has given this dignity to men and women. Let our prayers rise to heaven that the Lord may help us to come to the aid of the victims of abuse and care for them.

Pope Francis' Message for Lent: Meditating on the Transfiguration experience, Pope Francis invites the whole Church, during this Lenten season to have the synodal perspective. Amid ordinary and boring routines, during Lent we are invited to ascend "a high mountain" in the company of Jesus and to live a particular experience of spiritual discipline – *ascesis* – as God's holy people. Both the journey of penance and the synodal journey demand effort, sacrifice and concentration. They have the joy of Transfiguration as the goal, both personal and ecclesial. God's grace and our efforts must go hand in hand; thereby we acquire the knowledge of the Master and experience his salvific love.

The Pope focuses on two ways reflected in the Transfiguration scene. The first is to heed the voice heard at the mountaintop: "This is my beloved Son, with whom I am well pleased. Listen to him". When we journey together with others in the Lenten ascesis, we must give priority to listen to the Word of God, proclaimed during the liturgical celebrations, meditated in our communities and in our private reading. The Lord will reveal his will and our mission in the service of the Kingdom if we attentively listen to Jesus. The Supreme Pontiff affirms: "listening to Christ often takes place in listening to our brothers and sisters in the

Church. Such mutual listening in some phases is the primary goal, but it remains always indispensable in the method and style of a synodal Church". Listening lovingly could be taken as Lenten practice of penance.

In the second way, the Pope insists that we, like Peter, James and John, fall prostrate before the Lord both in fear and in adoration. We are invited not to "take refuge in a religiosity made up of extraordinary events and dramatic experiences, out of fear of facing reality and its daily struggles, its hardships and contradictions". These days, there is a tendency to go after the miraculous and extraordinary, but Jesus always proposes that the joy of Resurrection awaits those who are ready to walk with him on the way of the Cross. He never promises miracles to attract people to himself. Instead, he places the Resurrection as our goal and Transfiguration as its preview, and everything else will find its own place. Naturally, then, almsgiving, prayer and fasting will also be meaningful to us.

Pray for Pope Francis: On 13 March, Pope Francis completes 10 years after his election as the Supreme Pastor of the Church. At every discourse, he has one request to make: "Please do not forget to pray for me". He deeply trusts in the power of intercession and sets himself as a wonderful example of humbly asking for prayers. Prayers of intercession are precious, and Pope Francis teaches us, by his example, that the Lord hears the cry of his people. Therefore, let us pray intensely for our beloved Pope, who desires our participation in his ministry through our prayerful support and let us intercede for one another.

St Joseph, Patron of the Universal Church and of our Diocese: This year, the Solemnity of St Joseph is celebrated on 20 March. In his Apostolic Letter *Patris Corde*, Pope Francis underscores the tenderness with which St Joseph cared for Mary and Jesus. As a tender and loving father, St Joseph loves us too and teaches us that "Tenderness is the best way to touch the frailty within us. Pointing fingers and judging others are frequently signs of an inability to accept our own weaknesses, our own frailty. Only tender love will save us from the snares of the accuser (cf. Rev 12:10). That is why it is so important to encounter God's mercy, especially in the Sacrament of Reconciliation, where we experience his truth and tenderness" (n. 2). In this month, as

we walk through the Lenten practices to ascend to the mountain of holiness, let St Joseph teach us to tenderly love one another. May the Sacrament of Reconciliation be a wonderful occasion to experience God's tenderness and mercy towards us.

Solemnity of the Annunciation of the Lord: The great mystery of incarnation, which we recall every day, at least thrice, during the *Angelus*, reminds us of the centrality of God becoming man. From this day of Annunciation, 25 March, Christmas is nine months away. Already, in the Lenten Season, we contemplate the birth of our Saviour. May the Church bell that invites for prayer of *Angelus* in the morning, noon and in the evening, be a call for us to contemplate the mystery of God's incarnation and our own divinisation.

Message of the Conference of the Catholic Bishops of India (CCBI): Through the recently concluded CCBI meeting, with the theme, "Telling the Story of Jesus in our Context: The Synodal Way" held on January 24-30, 2023, at St. John's National Academy of Health Sciences, Bangalore, the Bishops invite all the faithful to recount the story of Jesus in our context. The synodal path we have begun traversing is the framework, in which we can encounter many co-pilgrims who desire to know Jesus, love him and be loved by him. The Bishops place before us the importance of the family in telling the story of Jesus. As we have dedicated this year to families, this message is meaningful to us: "This love of God is lived and experienced first and foremost in the family, where the story of Jesus is recounted by grandparents and parents to their children in various ways, by reading Bible stories, praying together and participating in popular devotions". Parents must be encouraged to narrate to children the stories from the Bible, and the message of the parables so that they get deeply rooted in faith. Further, the CCBI also highlighted the importance of the Basic Ecclesial Communities in telling the story of Jesus. There we read and meditate on the Word of God and get down to action after listening to the Word. May these two intimate realities be effective instruments to make Christ known and loved

POINTS TO CONSIDER WHILE ISSUING RECOMMENDATION LETTERS FOR CHARITY

Dear Rev. Fathers, some of you recommend parishioners for charity towards medical, housing, and educational needs to the Bishop. Naturally, we help financially with whatever amount is available to deserving persons. But, identifying the deserving individuals is difficult until the genuine circumstances are disclosed in the appeals written to the Bishop requesting charity. Hence, when you recommend such appeals, we advise that you adhere to the following guidelines:

- 1. The request letter of the person seeking charity/assistance should have the following: the full postal address, the mobile number, the Parish and the ward name. The name should be the same as in the bank account.
- 2. The financial situation of the family and the explanation of the need or justification for assistance should be clearly stated in the appeal letter.
- 3. The estimated total cost (amount) of the need is also to be mentioned. For example, the cost of medical treatment, the total cost of the house repair/building anew (size of the house in square feet), total fees for educational purposes including other expenses etc.
- 4. The Parish Priest need not write a separate letter, but he must confirm the facts and the reasons stated in the appeal and write on it a note of recommendation to the Bishop, with his signature and the seal of the church.
- Please encourage those in need to take advantage of all government assistance schemes or programmes and urge the parish community to help its members like the early Christian community.

Hereafter enrolment of Extraordinary Ministers' data (online) is mandatory. Some parishes have already done it. Those who have not completed it, please do the needful before 31 March 2023. 2. Diocesan Level Catechism and Value Education Day 2023:

Mangala Jyothi will be conducting diocesan level Catechism Day and Value Education day on 05 and 06 March 2023 from 09 a.m. to 02 p.m. at Pastoral Institute, Jyothi Nivas Hall I. The top scorers of X std students will be felicitated on these days. I am happy to inform you that Mangala Jyothi will be completing 50 years of service in the year 2023. We will be inaugurating the Golden Jubilee Year on 05 March 2023. You are cordially invited to the programme.

3. New Value Education Series 2023:

As per the request of students, teachers, and priests, we had initiated the process of preparing the new series of Value Education books in the year 2019. Teachers of ten schools of our diocese have done the initial draft. Then we had selected teachers from 6 schools to rework the text. The books are now published at the national level by CCBI in collaboration with ATC. I'm grateful to the editorial board and all those who have contributed towards this publication. Catechism and Value Education are mandatory for all the students of our school. However, we have noted that some schools are not conducting this course. Some are conducting the classes only for VII and X. Hence, I request all the correspondents to give attention to this issue and ensure that all the schools organise the catechism and value education in your jurisdiction. Let us not hesitate to impart faith as well as value education to our students because it is our primary responsibility.

4. New Catechetical Year 2023:

New catechetical year begins on 04 June 2023. Hence inauguration of the activities will be held on that day. More details will be sent to you soon.

5. YOUCAT Ministry:

We have already introduced YOUCAT book and its relevance to the 210 youth representatives of the diocese at DYC. We have asked them to spare 15 minutes during their meeting and use at least one question and answer from the YOUCAT for the study. Kindly encourage the youth to possess a copy of the YOUCAT, which is available in Konkani and English at our store. Konkani version is made available at the subsidised rate of Rs 200/-. YOUCAT strengthens the faith of the youth, and also it has answers to their existential issues. YOUCAT daily app is also available now for the android system. It includes daily YOUCAT question-answer, YBIBLE passage, and an inspiration quote. Young married couples can also use it. Please inform all the youth and young couples of your parish. Soon we will begin YOUCAT network study groups and other related activities for the youth of our diocese.

Golden Jubilee Year of CODP: Guidelines from CODP Diocesan Building Programme Committee to Select the apt Beneficiaries for the Programme:

- 1. The area of the house to be constructed will be 650-700 sq feet
- 2. Those who have their own land shall be given preference with supporting documents.
- 3. CODP will provide 3 plans and estimates, including a plan for the tiled roof. Following are the three plans:
- 4. Plan 1 Tiled house with steel roof cost 7 lakhs
 Plan 2 661 sq feet cost 8 lakhs
 Plan 3 700 sq feet cost 8,47,201

 Terrace
- 5. From one parish maximum of one application can be submitted
- 6. An application can also be submitted for repair work
- 7. Applicant should have a minimum of 3 to 3.5 cents own land.
- 8. While constructing the house, the beneficiary seeks help from the Parish, local people, government or relatives. Through "Shramadhan" cost reduction is to be planned.
- 9. The Diocese of Mangalore, with the support of donours, will provide 51% of the funds for construction of the house and the balance should be provided by the applicant through different sources.
- 10. The application submitted by the applicant to the government should accompany the application given to the Jubilee Building Committee.
- 11. The beneficiary is selected by the Parish Priest, who will submit the applications after checking all the details with their recommendation to the Jubilee Building Committee.

- 12. The final approval of the application will be by the Jubilee Building Committee.
- 13. For repair of the house, the committee will check the need and cost details by visiting the house.
- 14. Separate applications for repair works (two) can be given.
- 15. Parish Priest or duly delegated committee should be responsible for all contact and communication.
- 16. Applications are called from the families of Mangalore Diocese only.

XXXIV PLENARY ASSEMBLY

Theme: 'Telling the Story of Jesus in our Context: The Synodal Way''

January 24-30, 2023, St. John's National Academy of Health Sciences, Bengaluru.

MESSAGE

We, the members of the Conference of Catholic Bishops of India (CCBI), came together for the 34th Plenary Assembly from 24 to 30 January 2023, at St. John's National Academy of Health Sciences, Bengaluru. We prayed, reflected on and discussed the theme: 'Telling the Story of Jesus in our Context: The Synodal Way.'

The Church, as the People of God, is the icon of the Holy Trinity, called to live in communion of love by participating in the one mission which emanates from the Triune God. The Apostle John

testifies: "That which was from the beginning, which we have heard, which we have seen with our eyes, which we looked upon and have touched with our hands, concerning the word of life ... we have seen it, and testify to it and proclaim to you the eternal life ..." (1 John 1:1-2). This calls for a personal encounter with our Lord Jesus Christ, which itself urges us to live and joyfully share the Good News in our context. Christ commissioned his Apostles: "Go into all the world and proclaim the gospel to the whole creation" (Mark 16:15). The Church continues this mission, living it by her words and deeds. This Good News is Jesus Christ himself, in whom God's love in all its fullness is manifested to the whole of humanity. The Church, in the midst of her ups and downs, lights and shadows, successes and struggles, has striven to be faithful in bearing witness to this love of God in our beloved Motherland.

Down the centuries, millions have been attracted to the person of Jesus Christ and his salvific message and have become his followers. Through them the story of Jesus is told and retold, fulfilling what the Church has been proclaiming from the very beginning: "Truly I understand that God shows no partiality, but in every nation anyone who fears him and does what is right is acceptable to him" (Acts 10:34-35).

This love of God is lived and experienced first and foremost in the family, where the story of Jesus is recounted by grandparents and parents to their children in various ways, by reading Bible stories, praying together and participating in popular devotions. The faith life is further nourished and sustained in the larger family of the parish, where the celebration of the Holy Eucharist occupies the central place. The proclamation and the breaking of the word play an essential and prominent role in all the liturgical celebrations. The Holy Eucharist is the sacrament in which the community is being transformed into the body of Christ, where "There is neither Jew nor Greek, there is neither slave nor free, there is no male and female, for you are all one in Christ Jesus" (Galatians 3:28).

The story of Jesus is read, lived and shared in a dynamic manner and in a synodal way in the Basic Ecclesial Communities (BEC). The Gospel sharing in the BECs (also known as SCCs/BCCs) strengthens the bonds of communion and leads the members to bear witness in society.

Witnessing to the love of Christ, the Church in India has substantially contributed to nation-building, especially through her engagement in the fields of education, healthcare and social uplift. Standing firm on the teachings of Christ, the Church has always upheld the dignity of the human person, stood for a just society, promoted peace and harmony and cared for the weak, the suffering and the deprived sections of society.

From the very beginning, ordained ministers, along with women and men in consecrated life and ably supported by catechists, have been serving their communities both within and outside the Church, through committed pastoral care. The participatory bodies and lay associations foster communion and involvement of the members of the body of Christ in the mission of the Church.

The Catholic Church in India recognises the changing circumstances and growing challenges she has to face, but has never ceased to tell the story of Jesus. A few challenges have been identified:

- Changing social conditions and the excessive use of social media, mobiles and internet have placed enormous pressure on the harmonious life of families.
- Addictions to drugs, alcohol and pornography are ruining the lives of many young adults, causing disruptions within families and in society.
- Poverty and inhuman living conditions deprive a substantial part of our population of equitable opportunity and dignity of life, creating uncertainties about their future.
- Massive displacement of peoples, loss of land and fishing rights in the name of industrial and corporate development result in forced migration, dispossession, loss of livelihood and further marginalisation.

- Greed and consumeristic life styles are eroding the life of faith and centrality of prayer.
- Some civil legislations and policies often seriously hamper pastoral engagements of the Church in India.
- Misuse of anti-conversion laws in some States and false propaganda about 'forced conversions' are discouraging and hindering the life and service of the Christian community. This calls into question the Constitutional rights of the minorities.
- The growing culture of intolerance, hatred and even violent attacks on Christians in some quarters is a matter of grave concern to Christians in India.

In the present context, the story of Jesus needs to be told even more courageously, creatively and authentically, considering that the Good News is to be proclaimed in season and out of season (cf. 2 Timothy 4:2). Assured by the words of Jesus: "I have said these things to you, that in me you may have peace. In the world you will have tribulation. But take heart; I have overcome the world" (John 16:33), we continue to tell the story of Jesus, by the power of the Holy Spirit, that God loves everyone unconditionally.

Following the Synodal Way, let us:

- Accompany youth and families so that faith is deepened, family prayer is nurtured, and the bonds of communion are strengthened; also, foster respect for life from the moment of conception to natural death.
- As grandparents, parents and elders, continue to transmit the story of Jesus to the younger generations.
- As pastors and consecrated persons, take more seriously our responsibility to care for families, individuals and all to whom we are sent.
- Promote, foster and sustain BECs in all our parishes.
- Utilise the occasion of celebrations of the Eucharist and Sacraments to catechise and tell the story of Jesus in a meaningful way so that the people may experience the Lord in their lives.

- Stand in solidarity with those affected by persecution, displacement, discrimination and marginalisation.
- Make it our mission to protect and preserve mother earth (which Pope Francis has described as our 'common home' in *Laudato Si*), by employing all means at our disposal to promote eco-friendly lifestyles at all levels.
- Basing ourselves on the shared faith of all Christians, shun all fundamentalism and unitedly tell the story of love, justice and human fraternity.
- Join all our brothers and sisters, irrespective of caste, creed and language, to continue building our Nation, based on our Constitutional values in which justice, liberty, equality and fraternity reign supreme.
- Make efforts to uphold the secular ethos of our Nation with a preferential option for the deprived sections of our society, to ensure the integral development of all.

As we journey towards the celebration of the Synod in 2023-2024 and look forward to the Jubilee Year 2025, may all our efforts help us to be credible witnesses of Jesus Christ, while we continue joyfully to share his story.

On the occasion of the 74th Republic Day of our Nation, we pray for God's abundant blessings on our Motherland India. May Mary, our blessed Mother, who received, treasured and shared the Word, never cease to intercede for all her children.
