BISHOP'S MESSAGE FOR FEBRUARY 2024

Papal Intention for February: Pope Francis invites us to pray for the terminally ill. Many families experience insurmountable difficulties in facing these tragedies, and many times, they feel they are left alone. However much they spend their resources, their hopes get shattered. As a community, we feel for them and help them in one way or the other. It has been our experience that many Basic Ecclesial Communities come forward to help the neighbours. It is indeed a kind gesture. Let us participate in the pain and suffering of our neighbours so that they receive necessary physical and spiritual care and accompaniment.

February 2: Presentation of the Lord, Day of the Consecrated Life: The feast day on which we celebrate Joseph and Mary presenting Baby Jesus in the temple is a special day for the Consecrated men and women. We owe much to our religious brothers and sisters. This is a wonderful occasion to recognise their services in our Parishes, in the Church, in the Institutions, in Catechesis, in accompanying families in their pain and bereavement, and in the Basic Ecclesial Communities. I heartily recommend that prayers be offered for the intentions of our brothers and sisters and that some get-togethers be organised to celebrate their presence. Consecrated brethren are a strong witness to the presence of Risen Lord and his Kingdom in our midst. I am sincerely grateful to them. May the Lord bless all the Religious men and women.

Lenten Season begins: On 14th of this month, we celebrate Ash Wednesday, and with that, we enter into contemplating the Passion of our Lord. Suffering is part of our daily life, and hardly anyone is exempt from suffering. Our Lord Jesus, by his Passion and Death, has shown us the salvific value of suffering. Suffering and Death finally lead to the joy of Easter. The *Ordo* gives clear

instructions regarding Mass and Liturgy of the Hours during this season. Let us use this season to contemplate deeply the mystery of our redemption. Parish Priests are requested to alert the faithful about the penitential character of the season, whether in Liturgy or in any community celebration.

Logos, Banners and Decorations in the Sanctuary: The General Instruction of the Roman Missal (*GIRM*) desires that the decoration and other items in the sanctuary be arranged with moderation and well-balanced dignity, especially by avoiding or limiting the use of objects that have no direct liturgical function as much as possible. Non-liturgical objects or artefacts in the sanctuary that obstruct the clear view of the assembly or hinder the faithful's concentration on the celebration of the sacred mystery itself should be avoided.

Although artistic banners or logos relating to faith events of the parish, Diocese, or universal Church may be used on the day of their unveiling or inauguration, it is best to avoid placing them in the sanctuary at other times as they have no role in the liturgical celebration and tend to draw attention away from the centrality of the celebration. These logos and banners, while not constituting liturgical objects or liturgical aids, could serve a catechetical purpose, but the sanctuary is not a catechetical classroom or display area. As a result, these objects should preferably be placed in some other suitable place outside the sanctuary.

Both beauty and simplicity demand careful attention to each piece of liturgical furniture or object, each decorative element, as well as to the whole ensemble so that there is no clutter and no crowding. These various objects and elements must be able to breathe and function without being smothered by excess.

Second Phase of the Synod: The General Secretary of the Synod has sent the synthesis of the Report of the first session, celebrated from 4th to 29 October 2023. Now, as a preparation for the second session, we are asked to hold discussions on this report with the help of the questions sent. We have organised a discussion on 20th February at 3.00 p.m. in the Bishop's House,

and around 33 people from different walks of life are selected as indicated by the instructions sent to us. Based on the observations, we are asked to prepare a summary in three pages to be sent to the Central Coordinator, and then a final synthesis will be sent to Rome. Let us pray that our Church becomes truly synodal, walking with one another to spread the Good News of Christ.

Year of Learning and Prayer as Preparation for the Jubilee 2025: The clergy of our Diocese already had the input session on the Jubilee and on the Four Constitutions of the Vatican II. We have learnt the method of Conversation in the Spirit in listening to one another, and thus listening to the Holy Spirit. Now, we need to revisit these documents in our Parishes to involve the Lay Faithful and Religious using the same method in discussing the insights of Vatican II for our times to grasp what the Council unveiled regarding Jesus Christ. Jesus is the point of departure of our journey, the path to be traversed, and the goal to arrive at the end of our earthly pilgrimage. Christ is our beginning, Christ is our life and our guide, Christ is our hope and our end. The Jubilee must facilitate our encounter and intimate relationship with Christ, from whom we come, for whom we live and unto whom we go. Let this study and all our efforts have one total end: Jesus Christ, our pride and joy. The 35 books prepared as a help for our discussion are available in Mangala Jyothi.

In this time of preparation, Pope Francis invites us to a "symphony" of prayer. Wish you a blessed year of Prayer. May you learn to live in the presence of the Lord.

The Diocese is obliged to submit the diocesan data online to the Holy See by the end of February 2022. Therefore, this obligation makes it imperative that the deadline for submitting the completed forms must be met.

Please spare us the burden of calling and reminding you again. We need your cooperation, which we truly do value and for which we remain grateful.

BUDGET FOR THE YEAR 2024-2025

Please have the Budget for the coming Financial Year 2024-2025 approved by the Bishop by the end of March 2024. The Budget Format and Budget Items are given in the Inter Nos of March 2023, pp. 58-62. Please follow them. The Budget should be approved by the Parish Finance Council and sent to the Bishop for approval before the middle of March.

REGARDING ANNUAL RETURNS OF 2023-2024

The whole process of the audit of the annual accounts, the following procedure should be followed in succession:

- 1. The Internal Auditors should submit their Annual Report of the accounts for 2023-2024 at the beginning of the new financial year, 2024-2025.
- 2. Taking into account the Report of the Internal Auditor, the Parish Finance Council prepares the Receipts and Payments Account and the Parish Priest submits the annual accounts with all the necessary documents to the Chartered Accountant for audit.
- 3. The audited accounts (by the CA) should be presented to and approved by the Parish Finance Council (PFC).

- 4. The accounts approved by the PFC shall be submitted to the Parish Pastoral Council and shall be approved by the latter.
- 5. The accounts shall then be presented to the Parish Assembly during the Parish Assembly meeting or posted on the notice board after due notice has been given in the Sunday publication.
- 6. Finally, the annual accounts are submitted to the Bishop for his review, together with the reports of Nos. 1, 3, 4, 5 above and other appendices.

Please Note: The chartered accountants (CAs) have observed that requests for some changes cannot be accommodated once the audit process is completed on their part. Once the accounts have been uploaded to the Income Tax Department, it is not possible to revert the process. Therefore, the Internal Auditors and the Parish Finance Council should prepare the accounts carefully in the initial stages.

LENTEN CAMPAIGN 2024 - 'MY LENTEN SACRIFICE'

Dear Rev. Fathers. Brothers and Sisters in Christ,

We have begun this year with optimism and hope. I wish you a happy New Year 2024. On 14 February, we begin the Lenten season. As in the past few years, and this year too, we have decided to set aside a major portion of our Lenten sacrifice for the housing project in our Diocese. Many Parish Priests collect the Lenten sacrifice during the annual house blessing. Some begin blessing the houses already in January.

- 1) In the year 2023, we collected Rs 76,79,445/- for the cause of "Diocesan mission/charity activities". We thank all the Lay Faithful, Priests, Religious Brothers and Sisters who have contributed to the cause.
- 2) The collected amount is being utilised for the objectives of the campaign, namely housing, education, health, food, marriage of poor girls and medicine. In fact, a larger amount is set apart for housing from 2021.
- 3) As CODP approaches its Golden Jubilee in 2024, our objective is to assist 75 beneficiaries in constructing new houses. Over the previous three years, 1.39 crores had been set aside for housing projects.
- 4) We have disbursed Rs. 1,14,81,450/- from the income saved from the previous and current years for charity purposes in the year 2022-23.
