BISHOP'S MESSAGE FOR SEPTEMBER 2025

Papal Intention for September: The whole Church is invited to pray for the improvement of our relationship with the whole creation. From September 1 to October 4, the universal Church celebrates the *Season of Creation*. Reflecting on God's marvellous creation, St Francis of Assisi called them brother, sister and mother in his *Canticles of the Creatures*. Following his example, we are specially called upon to care for God's

creation. There is an intimate interdependence and harmony between all creatures as all are the handiwork of God. Pope Francis wrote in *Laudato Si*: "Nature cannot be regarded as something separate from ourselves, or as a mere setting in which we live. We are part of nature, included in it and thus in constant interaction with it" (n. 139). Let us give special attention to listen to the cry of the earth, the poor, and care for the whole creation (LS, n. 49).

New Mass for the Care of Creation: The Dicastery for Divine Worship and the Discipline of the Sacraments has provided a new Mass formulary, "Mass for the Care of Creation" (Missa Pro custodia creationis), along with the related readings. This new formulary is approved by the Roman Pontiff and it is made part of the Roman Missal under the section "Masses for various needs and occasions". The CCBI has invited the Church in India to celebrate this Mass on the first Sunday of September, September 7, and has provided guidelines for celebrating this day meaningfully. Mangala Jyothi will provide both the English and Konkani translations of the Mass formulary, ad experimentum, and the definitive translations will be circulated once the confirmatio is received from the Holy See. Pope Leo XIV celebrated the Holy Eucharist amid the beauty of God's magnificent works on July 9, 2025 at Borgo Laudato si' (Castel Gandolfo), calling it "the cathedral" of creation. I invite parish Churches and communities to celebrate the Mass for the Care of Creation on September 7, Laudato Sì Sunday.

Feast of the Nativity of the Virgin Mary, September 8: Our Diocese has a beautiful tradition of celebrating the Nativity of Our Blessed Mother with flowers, Novena, and special prayers. The new corn, unity of the family, and the girl child are our focus. The whole atmosphere around us with lush green surroundings brings feelings of tenderness and family bonding. Children are the centre of attraction. Every member of the family, living and the dear departed, is remembered with love. May Mother Mary intercede for our families, each member and the whole creation.

Diocesan Synodal Facilitation Team: The General Secretariat for the Synod of Bishops has invited all the Dioceses to form a Synodal Facilitation Team. This team will assist in implementing the conclusions of Synod 2021-24, and in animating synodal life in the Diocese. The synodal formation at the Parish and Deanery level will foster a culture of listening, discernment, participation, pastoral and missionary conversion. In light of the directives given by the General Secretariat and in response to the call of the XVI Ordinary General Assembly of the Synod of Bishops, the Diocesan Facilitation Team is hereby constituted, consisting of the following members:

Election of PPC and PFC Members: By December 31, 2025, the terms of the current Parish Pastoral Council and Parish Finance Council will have been completed. Therefore, the process for the election of the 2026-2028 Councils needs to be initiated. Please carefully review the Constitution of the Councils of the Diocese of Mangalore, promulgated in 2022. The norms of the Constitution should be strictly followed. A separate section in this volume of *Inter Nos* provides timelines; please follow them meticulously.

Renewal of Registration U/S 12A, 12AA, 12AB, and 80G of the Income Tax Act: The registration of Religious and Charitable Trusts for tax exemption expires on March 31, 2026. The application for renewal of registration has to be submitted to the Commissioner of Income Tax online in Form No. 10A at least 6 months before the expiry of the existing registration. That would mean the application should be submitted before September 30, 2025. Kindly contact your Auditor for the list of documents to be submitted and take it as a priority.

Issuing of Certificates: While preparing documents for Marriage please check whether the Baptism certificate is issued from the place of Baptism. It is clarified during the Council of Priests' Meeting that certificates are to be issued only from a place where the act is done (for a detailed explanation, see the separate section on this matter in this *Inter Nos*). Similarly, notifications of Marriage and Confirmation should be sent to the place of Baptism without fail. While issuing the computerised copy of the certificates, countercheck them against the handwritten registers to verify that all necessary entries are correctly made. It has been noted that errors creep in and they create greater problems.

Jeevan Jyothi Camps: In October, Jeevan Jyothi camps are held for children in the X standard. I truly appreciate the efforts undertaken to support the formation of adolescent students. I am sure you give special attention to preparing them for the challenges of adolescent life, faith formation, and matters related to their life-choices. I request that you seriously discuss vocation and commitment. It is important to guide them in proper discernment about God's call to the priesthood and religious life. Inspire boys to choose the priesthood for the Diocese.

Wish you a Happy Monthi Fest. May Mother Mary intercede for our families.

On August 26, 2025, at 10:30 a.m., the above representatives met for the first time as the General Body. Under the presidency of Rev. Fr Richard A. Coelho, Paldane, who was nominated as the Director of the Personnel Board by the Bishop of Mangalore (cf. Norms, 6d), they elected four members (cf. Norms 6c).

Accordingly, the **Priests' Personnel Board** will now be comprised of the following individuals for a three-year term, which commences on September 15, 2025:

I request the priests of the Diocese to extend their utmost cooperation to the Priests' Personnel Board. This enables them to carry out the crucial task entrusted to them, ensuring a smooth and effective administration for the benefit of the entire presbyterium and the good of the Diocese.

REGARDING THE ISSUANCE OF BAPTISM CERTIFICATES

During the Council of Priests' meeting on June 26, 2025, the issue of multiple entries on baptism certificates and the resulting problems was discussed. While the correct practice was brought to the members' attention, it is considered essential to communicate this to all priests and ensure it is followed. Therefore, the following directives are issued:

A baptism certificate is properly issued only from the Baptism Register maintained by the specific church where the baptism actually occurred. The Code of Canon Law explicitly states that "the Parish Priest of *the place where the baptism is celebrated* must carefully and without delay record in the Baptism Register the names of the baptised with the mention made of the minister, parents, sponsors ... the date of the conferral of the baptism..." (can. 877 §1, emphasis added). This register serves as the official record of baptisms performed at that church, and all related details should remain documented within its own records.

Issuing a baptism certificate by a church not involved in the actual baptism is an erroneous and problematic practice, just as issuing marriage certificates or death certificates by a church where such acts have not taken place. Moreover, entering baptism details into a different church's records can lead to significant confusion and inaccurate historical documentation. When a baptism is recorded in a church other than the one where it took place, and this church issues certificates, it undermines the authenticity and sufficiency of entries for other sacraments, such as confirmation and marriage. This can also create significant confusion, result in inaccurate historical records, and potentially lead to fraudulent issues, particularly at the time of marriage.

Therefore, a Parish Priest should always obtain the baptism certificate directly from the parish where the baptism actually occurred. Parishes or churches that have erroneously recorded a baptismal entry for a baptism that did not occur within their own jurisdiction are strongly advised against issuing a certificate. It is proper and lawful practice to issue certificates only from the original registers, and not from secondary or duplicate entries. This is consistent with the standard for other sacred acts, such as marriage, funerals, and ordinations, where only the church that performed the rite provides the official documentation.

Baptism certificates issued by a Church or ecclesiastical community are primary documents that record an individual's baptism and serve as an official record of their religious affiliation and participation. While some organisations or institutions may accept them as proof of identity or date of birth, this is not a universal standard, and they do not hold the same status as government documents for civil purposes. For official purposes in a civil context, a baptism certificate may not be a valid or primary document for proving an individual's date of birth. This is because government-issued documents—such as a formal birth certificate, passport, or Aadhaar Card—are the legally accepted standards. These government-issued documents enjoy a legal presumption of correctness under the Indian Evidence Act, 1872. As the Kerala High Court stated in Sminu vs. State Of Kerala on 23 August 2023: "The baptism certificate is issued by the Church to record baptism of a person. No primacy can be accorded to the baptism certificate when public documents are available indicating the date of birth."

FORMATION OF THE NEW COUNCILS IN THE PARISH

The term of the existing Parish Pastoral Council and the Parish Finance Council ends on 31 December 2025. I hereby call upon parish priests to form the new Parish Pastoral Council, its office bearers, and the Parish Finance Council, and thereafter to establish the various commissions in the Diocesan Pastoral Plan. The process of forming these Councils should begin from October 2025. The term of the new Councils will be from 2026 to 2028.

Please go through the Constitution of the Councils of the Diocese of Mangalore, promulgated in 2022, carefully. The norms of this Constitution should be strictly followed without any compromise.

The time schedule for the process of establishing the new Councils at different levels is as follows:

- 1. From October 1, 2025: the members of the Parish Pastoral Council, its office bearers, Parish Finance Council and other Commissions are to be elected.
- 2. Before March 31, 2026, form Deanery Pastoral Council
- 3. Before May 31, the Diocesan Pastoral Council is to be formed.

The formation of the Parish Pastoral Council, the election of its office bearers, and the formation of the Parish Finance Council should be completed well in time, and approval from the Bishop should be obtained by December 31, 2025. The new Parish Pastoral Council and the new Parish Finance Council come into effect from January 1, 2026.

When the list of Parish Pastoral Council and Parish Finance Council members is sent to the Bishop for approval, it should contain the following information:

- a) Name of the member
- b) Information on whether the member is an ex-officio, elected, nominated or honorary member
- c) Date of Birth of the members

- d) Educational Qualification
- e) In the case of the Vice President, Secretary, and Parish Finance Council members, their educational qualifications, mobile phone numbers, and contact addresses are to be provided.
- f) Declaration from the Parish Priest stating that the norms relating to the election, nomination and formation of the new Parish Pastoral Council and the Parish Finance Council have been followed, and the office bearers and members possess the eligibility for membership/offices in the Councils.

After completing the process of election and nomination of the members of the Parish Pastoral Council, its office bearers, and the Parish Finance Council, the details of the new members should be sent for approval in the format given below on pp.188-191, in duplicate, before December 15, 2025.

WORDS OF REMEMBRANCE (EULOGY) FOR MSGR ALOYSIUS D'SOUZA

"Blessed are the pure in heart, for they shall see God."
(Mt 5:8)

My dear Bishops, Reverend Fathers, Sisters, and family members of Msgr. Aloysius, and all my brothers and sisters,

We have gathered today to bid farewell to one of the oldest priests of our Diocese. As the Sermon on the Mount tells us, "Blessed are the pure in heart, for they shall see God." Monsignor Aloysius was a pure man, a humble priest. Pure in his words, pure in his speech, pure in his heart and mind. Pure throughout his long life of 100 years and 7 months. I am certain he has already seen God, and now the Lord has invited him to His table to dine with Him.

This holy priest was exceptional in many ways, and today we lift our hearts and minds to God in gratitude for the gift he was to our Diocese. The Lord gave him to us, and the Lord has taken him back. Blessed be the name of the Lord.

Monsignor Aloysius began his life in Puttur, born on January 29, 1925, the only son of Martin and Piedade D'Souza, pious and proud parents. He lost his father while still an adolescent and was lovingly raised by his devout mother, who encouraged and supported his vocation to the priesthood. He completed his early education in Puttur before joining our seminary and was later sent to Kandy for his theological studies. He was ordained a priest on August 24, 1953. By now, he has completed almost 73 years in priestly ministry.

During these years, he served in various parishes and institutions: 9 years as Assistant at Bejai; 1 year as Parish Priest at Arva; 1 year as Secretary to the Bishop; 8 years as Manager of the Codialbail Press; 8 years as Parish Priest and Vicar Forane at Pezar; 6 years as Parish Priest and Vicar Forane at Kinnigoli; 8 years as Vicar General of our Diocese; 5 years as Director of St Anthony Institutes; and more than 20 years as Spiritual Father

at St Joseph's Seminary, Jeppu. It is very interesting to note that during his hundred years, Monsignor has witnessed the tenure of 9 Popes and 7 Bishops of our Diocese. His priestly life reveals that he was a man of many talents who embraced ministry in varied forms, serving parishes, institutions, and formation houses, always connecting deeply with people in every circumstance.

Now, I would like to highlight four remarkable qualities of our dear Monsignor:

- 1. He radiated the joy of the priesthood. This holy centenarian lived the joy of priesthood fully and wholeheartedly. That joy shone in his words, his smile, his serenity, his love, and his sacrifice. There is a saying: "Happiness consists not in what a person possesses, but in what possesses that person." What possessed Monsignor? Not money, gold, or silver; not titles, buildings, or academic honours. What possessed him was the love of the Lord and the love of the Church. If Scripture tells us, "Obedience is better than sacrifice," then Monsignor lived this to the fullest. He was obedient to his superiors, to rules and regulations, to liturgical norms, and to the demands of a priestly life. His joy wasn't found in grand gestures, but in small things, because he believed in the God of small things. He believed in the God who became flesh and lived among us. His God was the God of humble people, and in small, daily events, he found Emmanuel—God with us and for us. Just as the Psalmist says, "Blessed are those who fear the LORD, who find great delight in His commands" (Ps 112).
- 2. He saw learning as a lifelong journey. The golden rule of his life was: "A seeker of knowledge is never at rest." For him, learning had no limits—no time, no place, and no age restriction. He was a teacher of Latin, proficient in English, and deeply versed in Konkani. He edited the diocesan liturgical book, Ordo, for more than four decades and corrected numerous articles and books in both Konkani and English. His knowledge of homeopathy was also remarkable. He even kept a small clinic in his room, helping many people regain their health. His curiosity was healthy and boundless, a sign of his active and disciplined mind.

- **3.** He was a man of rigour and rhythm. Monsignor Aloysius was a man of great rigour a quality that was almost synonymous with him. His disciplined daily schedule was a testament to this, with time set aside for the Breviary, Holy Mass, visits to the Blessed Sacrament, Examination of Conscience, Adoration, the Rosary, and a Holy Hour. His life was meticulously organised; his meals were orderly, his walks were at set times, and he kept regular office hours. He offered spiritual direction with precision and faithfully visited families in his parish.
- **4. He was free from earthly attachments.** He lived by the principle: "Be happy with what you have." His life was clean, sacred, and free from worldly allurements. I recall one night, years ago, around 11:30 p.m., when he called me. I was the Rector at the time, and he said, "Fr. Rector, I am not feeling well." When I arrived, he was seated in his chair. He asked to make his confession, which I heard. He then showed me where his books and documents were kept. I urged him to go to the hospital, but he refused, saying he was ready to go whenever the Lord called him. He truly followed the Pauline principle: "For to me, to live is Christ and to die is gain" (Phil 1:21). Here was a priest wholly given to service, expecting nothing in return.

Dear Monsignor Aloysius, today we say our final farewell. We thank you for your holy, committed, and sincere life as a priest of our Diocese. Thank you for being a living example of priestly joy and dedication. Thank you for teaching us more through your deeds than your words about the sacredness and beauty of the priestly vocation. Thank you for walking the path of the Beatitudes and leaving us a rich spiritual legacy. May you now enjoy eternal bliss with the angels and saints. Pray for us, our Diocese, our priests, our parishes, our institutions, and all our people.

Eternal rest grant unto him, O Lord, and let perpetual light shine upon him. May he rest in peace. Amen.
